**a. Review of ‘Letters of Interest’ submitted for town attorney position** - Mayor Simons summarized that in late 2008, based on Board decision a request went out for letters of interest for the position of town attorney. We received a dozen responses; tonight we would like to discuss these proposals. Vice Mayor Deighton commented that he reviewed the proposals and they seem comparable to present attorney’s contract, except for the travel time billings. He was satisfied with the service. Commissioners Drillick and Fox agreed. Commissioner Steiermann wants to pursue conversation discussing the travel time billings and service. Board discussion ensued; there were No Public comments. Commissioner Steiermann was appointed liaison to meet with Attorney Salzman. Town Clerk will send out thank-you letters to the applicants, reiterating that, at present, we are in contract with Andrew Salzman.
