- a. **Final budget hearing for Fiscal Year 2009-2010** – Mayor Simons summarized the budget process; with recommendations from the Finance Committee the Board adopted the tentative millage in July; the Finance Committee worked with the Town staff in preparing the budget, it was work shopped in August and the first public budget hearing was held September 3rd. Mayor turned the session over to Vice Mayor Deighton.
