## OLD BUSINESS

**a. Special detail deputy update** – in the absence of Commissioner Dorgan, Vice Mayor Steiermann spearheaded the discussion to contract with the sheriff's office for special detail deputy to cover the Town's seven crosswalks during weekends in July. Board discussion ensued, with Public input. **Motion** made by Vice Mayor Steiermann and seconded by Commissioner Will to contract for a special detail officer to work July Holiday, Saturday/Sunday, 4 hrs. each day to coincide with N. Redington's scheduled hours. Coverage for Gulf Blvd. would be approx. 7 hrs. on each scheduled day. Town's fiscal 2009-10 Budget has \$1,000 allocated for this expense. Public comment from *David Drillick, 1<sup>st</sup> Street* – said coverage was okay, but the length of time was too much, we should monitor the speed instead of the crosswalks. *Erica Lynch, 163<sup>rd</sup> Ave.* – said we should educate the public on using the crosswalks. Mayor Simons added that FDOT will shortly be implementing crossing flags that will be placed on all Gulf Blvd. crosswalks. No further discussion or Public comments.

**b. Town roads and streets update** – Vice Mayor Steiermann said that Public Works Director Davis received two proposals for engineering services to prepare the specs and bid package for Town roads and street project. The costs were \$4,000 or \$25,000. Board discussion and **consensus**, that this would be an agenda item for the July 6<sup>th</sup> Board meeting, to chose an engineering firm and proceed with the project.

## NEW BUSINESS

**a. Appointments to the Board of Adjustment** – Ken Sulewski, Redington Drive thanked the Board for considering him for reappointment to the Board of Adjustment. **Motion** made by Commissioner Deighton and seconded Commissioner Will to reappoint Ken Sulewski to a full three year term on the Board of Adjustment, term to expire June 15, 2013.

**RESOLUTION 2010-07**

**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE TOWN OF REDINGTON BEACH, FLORIDA AUTHORIZING TRANSFER OF FUNDS FROM SBA (a) ACCOUNTS, STORMWATER, CAPITAL AND GENERAL TO FIFTH THIRD BANK RESPECTIVE ACCOUNTS; AND PROVIDING FOR AN EFFECTIVE DATE.**

Attorney Sirico read the Resolution by title. **2nd Reading of Ordinance 10-07**

**ORDINANCE NO. 10-07**

**AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE TOWN OF REDINGTON BEACH, FLORIDA SUBMITTING TO THE TOWN ELECTORATE, REFERENDUM QUESTION ON AMENDMENT TO THE TOWN OF REDINGTON BEACH CHARTER SECTION 5, TOWN OFFICERS GENERALLY, (B) SALARIES (1) COMPENSATION FOR THE MAYOR AND (2) COMPENSATION FOR COMMISSIONERS; INCREASING THE COMPENSATION FOR THE MAYOR TO \$500.00 a MONTH; INCREASING THE COMPENSATION FOR COMMISSIONERS \$300.00 A MONTH; SAID REFERENDUM QUESTION TO BE ADDED TO THE GENERAL ELECTION BALLOT ON NOVEMBER 2, 2010; ESTABLISHING THE QUESTION TO APPEAR ON SAID BALLOT; PROVIDING FOR PUBLICATION IN ACCORDANCE WITH LAW; AND PROVIDING FOR AN EFFECTIVE DATE.**

Attorney Sirico read the ordinance by title at its 2nd reading. Mayor Simons said, at previous meetings, resident Poul Madsen brought it to public attention that the Board was not adequately compensated for their work. The method of placing the question on the ballot is either by citizen initiative or by adopted ordinance. Ordinance 10-07 was first read and adopted at the May 18 Board meeting. **Motion** made by Commissioner Will and seconded by Commissioner Deighton to adopt Ordinance 10-07 at its 2nd reading. Public comment from Poul Madsen, 6<sup>th</sup> St. - said the language of ordinance should state the exact amount of salary, not use the word increase. The ballot question will be drafted by the Attorney and Town Clerk. **Roll Call Vote:**
