**Public Safety – Commissioner Dorgan**

- In discussion with Pinellas Sheriff’s office, the feasibility of having a speed monitor set up on 156<sup>th</sup> and 157<sup>th</sup> Ave. is doable. A resident, via email, offered their property for location of the trailer, this will be pursued within the next week.

Attorney Le read the Resolution by title. Commissioner Deighton stated that Larson Allen has provided auditing services to the Town since the audit of 2005 (Valenti, Hernandez P.A.). The Board and staff have good relations and audit is conducted competently and economically. No Board discussion. **Motion** made by Commissioner Deighton and seconded by Commissioner Will to adopt the agreement letter from Larson Allen for three years [2011, 2012 and 2013] of auditing services at a fee of \$21,000 annually.

b. **Attorney Contract** – Attorney Le requested that this item be deferred to May 3 Board meeting, when Town Attorney Sirico will be present. Board discussion ensued to how the Town Attorney’s settlement of present and past litigation issues were not in Town’s favor; and firm does not seem to take a pro-active stance in pursuing settlements. Board could not be dissuaded to defer to May meeting, **Motion** was made by Vice Mayor Steiermann to implement the 90 day termination notice, as stated in the Town/Attorney contract, seconded by Commissioner Deighton.

**ORDINANCE**

**ORD. 11-03**

**AN ORDINANCE OF THE BOARD OF COMMISSIONER OF THE TOWN OF REDINGTON BEACH, FLORIDA AMENDING APPENDIX A OF THE TOWN CODE OF REDINGTON BEACH, FLORIDA BY AMENDING SECTION 8, PENALTY; AND PROVIDING FOR AN EFFECTIVE DATE.**

Attorney Le read the ordinance by title. This is the 1<sup>st</sup> reading of ordinance moved from Workshop. Town is involved in litigation regarding the short term rental code in Appendix A. In recent Elliott case, the judge dismissed the case due to ‘incarceration’ phrase in Town code. Ord. 11-03 is drafted to amend Sec. 8; the penalty; the amount is being changed to \$250 per day per violation and not to exceed \$500 per day per repeat violation and deleting the imprisonment phrase. The fine amounts are set per state statutes. Discussion of the Board followed as to the imprisonment phrase in other Town codes, the severity of the fine and next process in the litigation of the Elliott case. **Motion** made by Commissioner Dorgan and seconded by Vice Mayor Steiermann to adopt Ord. 11-03 at its 1<sup>st</sup> reading. **Roll Call vote:**
