**RESOLUTION 2011-04**

A RESOLUTION OF THE BOARD OF COMMISSIONERS FOR THE TOWN OF REDINGTON BEACH, FLORIDA STRONGLY URGING THE FLORIDA STATE LEGISLATURE TO RECOGNIZE AND RESPECT THE ROLE AND RESPONSIBILITY OF LOCAL GOVERNMENTS IN PROTECTING THE QUALITY OF FLORIDA WATER BODIES; TO RESPECT AND UPHOLD THE UNANIMOUS RECOMMENDATION OF THE CONSUMER FERTILIZER TASK FORCE; TO SUPPORT LEGISLATION THAT IS FISCALLY RESPONSIBLE; TO SUPPORT MEASURES RECOGNIZING THAT THE GOVERNMENT CLOSE TO THE PEOPLE IS BEST ABLE TO OVERSEE THE HEALTH OF THEIR LOCAL WATER RESOURCES; DIRECTING THE MAYOR TO FORWARD A COPY OF THIS RESOLUTION TO THE GOVERNOR, THE HOUSE OF REPRESENTATIVES AND THE MEMBERS OF THE PINELLAS COUNTY LEGISLATIVE DELEGATION; DIRECTING THE MAYOR TO FORWARD A COPY OF THIS RESOLUTION TO THE FLORIDA LEAGUE OF CITIES, FLORIDA ASSOCIATION OF COUNTIES AND FLORIDA STORM WATER ASSOCIATION; AND PROVIDING FOR AN EFFECTIVE DATE.


Attorney Sirico read the Resolution by title. Resolution 2011-04 is being adopted to facilitate the State legislature to pass measures that are fiscally responsible and not minimize local regulations regarding fertilizer expulsion into the waterways. No Public comments or Board discussion. **Motion** made by Vice Mayor Steiermann and Seconded by Commissioner Will to adopt Resolution 2011-04.
